NWRG HUB Tour: Victoria, BC in '23'

Greetings from the Northwest Regional Model A Group. We will be hosting the HUB Tour in Victoria, BC along with the Van-Isle A&B Fords group. Remember, this isn't a meet, it's a non-sanctioned HUB Tour.

Host Hotel

The HUB of the Tour will be the Four Points by Sheraton Victoria Gateway hotel (which is actually a Marriott). When you click on the link on the registration form, it will take you to the hotel's website with a guaranteed room rate of \$209/night Canadian. This equates to approximately \$156/night in U.S. funds at the current exchange rate. A block of rooms has been reserved for the HUB Tour beginning Monday, September 18 through Thursday, September 21.

Chronologically, here are the major events:

September 18, 2023 (Monday)

We will begin registration check-in on the evening of September 18 at the Four Points Sheraton Victoria. Look for the registration table in the lobby.

September 19, 2023 (Tuesday)

We are kicking off the event with registration at 8:00 a.m. for those coming into Victoria that morning. Breakfast will be at 9:00 a.m. where you will be receiving a HUB Tour booklet with all of the available tours listed. After breakfast you are free to take any of the tours, or take off and explore the Victoria area on your own.

September 20, 2023 (Wednesday)

More touring on your own, Restorers Class Evaluations start at 9:00 a.m., Hubley check in at 4:00 pm, NWRG Representatives meeting in the Hubley room at 5:00 pm, dinner on your own and Hubley races start at 7:30 p.m.

September 21, 2023 (Thursday)

Grand tour will include sites around Victoria and will stop at a farm for lunch. The lunch will be BBQ chicken hosted by the VanIsle A&B Fords with help from the Lion's Gate club. After lunch you will be free to tour on your own, explore downtown Victoria or take a nap. The Farewell Dinner will be at 6:00 p.m.

September 22, 2023 (Friday)

Hotel check out and travel home or stay on Vancouver Island for an extended stay. Extended stays should be arranged by individuals attending the event.

Registration Form

Print the registration form and waiver, fill them out and mail both along with your check or money order in US funds to Linda Harding, Treasurer of the NWRG. If you omit the waiver your registration will be returned. Linda's address is on the registration form. Canadians please convert to U.S. funds, at current exchange rate, and mail a money order to Linda.

Getting There and Back

You will need to check the ferry schedules leaving from Port Angeles and Vancouver. Please reserve the trip so you can avoid being on standby and waiting for the next ferry to depart.

There are three sailings a day from Port Angeles so for those traveling from a long distance and plan to use the ferry on September 18, you may want to spend a night in Port Angeles or other nearby town on September 17. See the following link for more info.

If you're trailering your car and only want to drive your Model A onto the ferry, we've made parking arrangements at:

Port Angeles: If you're driving through NW Washington state, please drop your truck/trailer off at: Jerry & Carol Weiler ● 366 Weiler Road ● Port Angeles. They have a private air strip where you can park your truck/trailer. The air strip is about 2 miles from the Port Angeles ferry terminal. If you get lost call Jerry & Carol at (360) 452-3096 for directions.

Vancouver, BC: If you're trailering your car through Vancouver, please drop your truck/trailer off at: Mike Breed • 19759 28th Avenue • Langley, BC. There is a gravel driveway next to their house that leads to the parking area in back. If you get lost call Mike at (604) 341-3997 for directions.

If you're trailering your Model A into Victoria (and we hope you won't) you will be directed to a farm about 10 miles from the host hotel. There is limited parking at the hotel, but there is plenty of space for the Model A's only.

U.S. citizens need to bring a passport and/or an enhanced drivers license, car registration, title and proof of insurance to get into Canada and back to the U.S. Make sure you have International Calling on your cell phone in case you need to call the Trouble Truck while on Vancouver Island.

Hotel Parking

The hotel has one parking lot; however, they will block off their lot directly in front of the hotel so we'll be visible to people passing by and it will be a short jaunt to the front door.

Restorers Class Evaluations

Name Tags

If you have a box full of lanyard name tags from previous NWRG meets, pick out your favorite and bring it to the hotel with your name and affiliated club listed on the identification label. If you prefer, wear your MAFCA name tag. If you don't have either, a name tag will be provided when you register.

Dress Code

Unless you're going to the Empress Hotel for tea, the dress code will be casual throughout the HUB Tour and business casual or era fashions for the Farewell Dinner. *Era wear is encouraged.*

Registration Deadline

The deadline for HUB Tour registrations is July 21, 2023. *The cost of registrations after July 21 increases to \$150.00 so early registration is encouraged.* If for some unforeseen problem arises and the event has to be cancelled, your registration fee will be refunded. If we have way more than 50 registrations and make money on this event we will donate the proceeds to the MAFCA Youth Restoration Fund and MAFCA Youth Scholarship Fund.

Plan on checking out of the hotel on Friday morning and don't forget to reserve the ferry.
