

# NWRG Hub Tour: Redmond, OR in '24'

Greetings from the Northwest Regional Model A Group. We will be hosting the Hub Tour in Redmond, Oregon along with the High Desert A's. Remember, this isn't a meet, it's a non-sanctioned Hub Tour.

## Host Hotel

The Hub of the Tour will be the Sleep Inn & Suites in Redmond, Oregon. We have a guaranteed room rate of \$139/night USD. A block of rooms has been reserved for the Hub Tour beginning Sunday evening, September 8<sup>th</sup> through Thursday, September 12<sup>th</sup>. The Redmond Swap Meet is September 7<sup>th</sup>; if you're coming in early to participate in the Swap Meet you will receive the Group Rate. If you'd like to stay a few days after the Hub Tour, you'll also receive the Group Rate. ## *Chronologically, here are the major events:*

### **September 8, 2024 (Sunday afternoon)**

We will begin early registration on the evening of September 8<sup>th</sup>, 4:00 – 6:00 p.m., at the Sleep Inn & Suites in Redmond, Oregon. Look for the registration table in the breakfast area. Open 4:00 – 6:00 p.m.

### **September 9, 2024 (Monday)**

Registration will begin at 8:00 a.m. at the Sleep Inn & Suites Conference Center. Because most of the area hotels offer a breakfast, we will **not** be having breakfast, but you'll want to attend the kick off meeting to find out about the week's events, meet old friends and make new acquaintances. You will receive a Hub Tour booklet containing the schedule and all of the available tours listed.

### **September 10, 2024 (Tuesday)**

Touring on your own. Restorers Class Evaluations start at 9:00 a.m. Tailgate Swap Meet is from 2:00 to 4:00 p.m. Hubley check in at 4:00 pm, NWRG Representatives meeting at the Sleep Inn & Suites Conference Center at 5:00 pm, dinner on your own and Hubley races start at 7:30 p.m.

### **September 11, 2024 (Wednesday)**

Grand tour will include sites around Central Oregon and will stop at Baldy's BBQ in Redmond for lunch between 1:00 – 2:30 p.m. After lunch you will be free to tour on your own, explore downtown Sisters, Redmond, Prineville, Bend; fly fish the Deschutes, Crooked or Metolius rivers or explore the many antique shops in the area.

### **September 12, 2024 (Thursday)**

More touring on your own and Farewell Dinner at 6:00 p.m. at the Sleep Inn & Suites Conference Center. No-host bar will open at 5:00 p.m.

### **September 13, 2024 (Friday)**

Hotel check out and travel home or, if you're superstitious and don't want to travel on Friday the 13<sup>th</sup>, stay in Redmond for a few extra days. Extended stays should be arranged with the hotels by individuals attending the event.

## **Registration Form**

***Print the registration form and waiver, fill them out and mail both along with your check or money order in US funds to Linda Harding, Treasurer of the NWRG.*** If you omit the waiver your registration will be returned. Linda's address is on the registration form. Canadian friends: please convert to U.S. funds, at current exchange rate, and mail a money order to Linda. If you registered and attended the Hub Tour in Victoria, be sure to subtract \$50 from your registration total.

### **Trailer Your Car?**

If you're trailering your car and staying at the Sleep Inn & Suites, you can park in the back part of the parking lot. If you're staying at the Best Western, Comfort Suites, SCP Redmond Hotel or elsewhere, please make arrangements with those hotels.

### **Hotel Parking**

The hotel has one parking lot; however, they will block off their lot directly in back of the hotel for Model A's only. If you're driving a modern car please park in front.

### **Name Tags**

If you have a box full of lanyard name tags from previous NWRG meets, pick out your favorite and bring it with you to the registration table. You will receive a Hub Tour name/club label to insert into your name tag. If you prefer, wear your MAFCA name tag. If you don't have either, a name tag will be provided when you register.

### **Dress Code**

The dress code will be casual throughout the Hub Tour and business casual or era fashions for the Farewell Dinner. Era wear is encouraged.

### **Hospitality**

Instead of renting another room, we're having our hospitality room in the breakfast area of the Sleep Inn. They will bake fresh cookies and will be serving beverages. This location will be a good place to rendezvous and go over the touring schedule with your friends.

### **Raffle**

We do not have a club to manage a raffle room so we're not conducting a raffle of gifts this year. Instead we are holding a Tailgate Swap Meet.

### **Tailgate Swap Meet**

Bring any Model A era items you want to sell and we'll have a section of the parking lot reserved for your Model A pickup, car or AA truck. Era fashion sellers and collectors are encouraged to participate.

### **Registration Deadline**

The deadline for Hub Tour registrations is July 19, 2024. ***The cost of registrations after July 19<sup>th</sup> increases so early registration is encouraged.***

If for some unforeseen problem arises and the event has to be cancelled, your registration fees will be refunded. If we have way more than 60 registrations and make money on this event we will give you a break on next year's Hub Tour.

**MODEL A FORD CLUB OF AMERICA  
WAIVER, INDEMNIFICATION RELEASE AGREEMENT**

IN CONSIDERATION OF BEING PERMITTED TO VOLUNTARILY PARTICIPATE (AT MY REQUEST) IN THE EVENT OF MODEL A FORD CLUB OF AMERICA (“MAFCA”), ITS CHAPTERS, REGIONS AND/OR SPECIAL INTEREST GROUPS REFERRED TO BELOW (“EVENT”), I/We, THE UNDERSIGNED AGREE(S) TO THE FOLLOWING:

**1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE MAFCA, ITS CHAPTERS, REGIONS OR SPECIAL INTEREST GROUPS, THEIR EMPLOYEES, OFFICERS AND AGENTS (“Releasees”)** from all liability to the undersigned, his or her or their personal representatives, assigns, heirs, family members and next of kin (**“Releasors”**) for any loss, damage, or claim therefor on account of injury to the person or property of the Releasors, whether caused by any negligent act or omission or other fault of the Releasees or otherwise while the undersigned is participating in the Event or using any of Releasees’ facilities in connection with the Event.

**2. THE RELEASORS HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS** the Releasees from all liability, claims, demands, causes of action, charges, expenses, and attorney fees and all other costs resulting from my involvement in the Event whether caused by any negligent act or omission or other fault of the Releasees or otherwise.

**3. THE RELEASORS HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF PERSONAL OR BODILY INJURY, DEATH OR PROPERTY DAMAGE** while upon Releasee property or participating in the Event or using any Releasee facilities and/or equipment whether caused by any negligent act or omission or other fault of Releasees or otherwise. The Releasors expressly agree that the foregoing release and waiver, indemnity agreement and assumption of risk are intended to be and shall be interpreted and applied as broad and inclusive as permitted by applicable law.

**I ACKNOWLEDGE THAT I HAVE READ THE FOREGOING, THAT I AM VOLUNTARILY ENTERING INTO THIS AGREEMENT AND THAT I AM AWARE OF THE LEGAL CONSEQUENCES OF THIS AGREEMENT**, including that it prevents me, my personal representatives, assigns, heirs, family members and next of kin from suing the Releasees if I am injured or damaged for any reason as a result of participation in the Event.

**IF THE PARTICIPANT IS A MINOR, HIS OR HER CUSTODIAL PARENT OR LEGAL GUARDIAN MUST READ AND EXECUTE THIS AGREEMENT WHERE INDICATED BELOW.** I hereby warrant and represent that I am the legal guardian or custodial parent of the minor named below, who is a minor, and agree, on my own and said minor’s behalf to the terms and conditions of the foregoing agreement.

I understand that I may talk to my legal advisor about this agreement and I have either done so or chosen not to. I understand that I have the right and have been given the opportunity to object to and bargain about the provisions of this agreement. I am voluntarily signing this agreement and intend it to be the unconditional release of all liability to the greatest extent allowed by applicable law.

**BEFORE SIGNING, CAREFULLY READ THIS ENTIRE AGREEMENT:** If any accident, injury, death or damage to personal property occurs, you (by signing this agreement) will be giving up certain legal rights. If any part of this agreement is held invalid, the rest of the provisions shall remain in effect. If you do not understand anything in this agreement, you should not sign it and you should instead consult your legal advisor.
